Applications are invited from the residents of Punjab for making nomination to the Thapar University, Patiala on the basis of **Inter-Se-Merit** of JEE (Main) 2015. The application should be in the prescribed Performa along-with the relevant documents:-

A. ELIGIBILITY

- i) Children/Grand Children of those who have lost a bread winner owing to terrorist action or where such a person has suffered permanent disability of 50% and above as a result of terrorist action, or.
- ii) Children/Grand Children of riot victims, if someone in family, was killed between 31.10.1984 and 07.11.1984 in the riots in Delhi, Bakaro, Kanpur and other places, or.
- iii) Grand Children of freedom fighters, or
- iv) Children of Defence Personnel who were resident of Punjab and have since died in any operation including Kargil Operation 1999, whether in Punjab or outside Punjab/ India or
- v) Children/widows of Para-Military forces personnel, Punjab Police, PAP and Punjab Home Guards, Killed or disabled in action to the extent of 50% or more and children /wards of officers and Jawans of Punjab Police, PAP and Para Military forces, who are winners of President Police Medal for Gallantry or winners of Police Medal for Gallantry (Provided it is conferred by the President of India), including posthumous awardees.
- vi) Sibling (single) Girl Child or one of the Girl of parents having two or more girls and having no male child.
- vii) Student suffering from Cancer/AIDS/Thalassemia (The claimant candidate will have to submit a certificate as a proof from the National Medical Institute like PGI, AIMS etc. in support of his/her claim)

B. EARMARKING OF SEATS FOR THAPAR UNIVERSITY, PATIALA.

1. For Thapar University Patiala, the following seats (Total 25) would be given category wise:-

i) Category i and ii	-	7
ii) Category iii	-	4
iii) Category iv-v & vi	-	8
iv) Category vii	-	6

For the above 25 seats of Thapar University, Patiala candidate must have passed 10+2 or equivalent examination with at least 60% marks (55% for SC/ST candidates) in aggregate of three subjects, namely, Physics, Mathematics and any one subject out of Chemistry, Biology, Biotechnology and Computer Sciences along with JEE (Main)-2015 OR minimum 60% (55% for SC/ST) marks in a Diploma recognized by AICTE or a State Board of Technical Education of at least 3 years.

C. CRITERIA FOR SEAT ALLOCATION

The following procedure would be followed to allocate branches as per their preferences –

- i) After scrutiny of documents and certificates etc. the eligible candidates would be categorized as per the above mentioned four categories in order of **Inter-Se-Merit** of JEE (Main) 2015.
 - ii) Thereafter the merit list of all categories would also be prepared.
 - iii) Thereafter the nomination process will start with the candidate of the category having highest **Inter-Se-Merit** among the toppers of all categories and it will be followed by the second highest ranking candidate of the toppers of all categories and then third highest and followed by fourth topper.
 - iv) After nominating one candidate from each category the same process will be repeated again starting with the category having a candidate with next highest **Inter-Se-Merit** except the category "ii" (Because this category is getting half weightage compared with other categories).
 - v) Same process will continue by repeating steps mentioned above till all the seats are filled.
 - vi) If there is no candidate available from any sub-category, the procedure would not stop and would move further.
2. By repeating this process, the nominations shall be made and the preference/option given by a candidate shall be taken into consideration, in accordance with order emerging out of this process.
 3. After completing the above mentioned process if some seats remain vacant they will be offered to the wards of the officers/employees of Punjab Police holding President's medal for meritorious/distinguished service in order of **Inter-Se-Merit** and still if some seats remain vacant, they may be offered to the candidates belonging to General category in order of **Inter-Se-Merit**

The Candidate should be resident of Punjab in terms of Punjab Govt. letter No. 1/03/95/PPII/9619 dated 06.06.1996 as amended from time to time. In case of riot victims relaxation may be given from the requirement of residence provided detailed justification seeking relaxation on production of residence certificate with documentary evidence in support of claim is attached with the application.

Counseling of the candidates for nomination seats shall be held on **27.07.2015 at 10.00 a.m.** in the Committee Room of Directorate of Technical Education & Industrial Training, Punjab, Plot No. 01, Sector 36-A, Chandigarh. Only those candidates will be considered who have applied against the nomination seats. No separate letter for counseling shall be issued.
