Minutes of the meeting held on 01-08-2013 at 10.00 A.M. under the Chairmanship of Secretary, Welfare reg. launching of Website- Ashirwad

Issues discussed and decisions taken:-

- 1) The "Percentage of Marks in the Previous Exam" field should be made optional. Since the student who gets reappear and promoted in the next class, is eligible for the scholarship in the next class.
- 2) In case, student has made any-error (Which is expected of a number of students) which is detected at the institute level, there is at present no provision for correction, neither at institute level, nor at student level. A number of such queries are being received by line departments. At the institute level, there are two options, viz. "May be Accepted", " May be Rejected". It is decided that the earlier available option of **Temporary Rejection** needs to be restored where the institute will temporarily reject the application of the students and the application goes back to the students (unlocked). The students after correcting the application will apply again to the institute. NICMP will incorporate the temporary rejection in the institute login.
- 3) Whenever the new institutes and sanctioning authorities are created. If the password cannot be sent through email due to security reasons, the institute ID may be sent by email/SMS. The following text may be sent through email and SMS:-
"Your user ID is, for the password you are requested to contact your line department."
Similarly on resetting password the email and SMS should be sent "Your password reset".
- 4) Since the institutes were ported from the back end there are certain institutes which have been entered twice and need to be deleted. One such list has already been sent to NICMP. Rest of the departments will send their list shortly. These institutes may be deleted from the database.
- 5) Some of the courses to be added from the back end. These will be sent to NICMP through email by NIC Punjab. An interface should be built for this at Line Department level.
- 6) The MIS reports which are available with NICMP may be included on the scholarship portal of Punjab. If there is need for some extra reports and any modification required in present reports, the same will be sent to NICMP with format.
- 7) Any mail from the Welfare Department or line departments which forwarded by NIC Punjab after due verification to NICMP should be treated as an authenticated communication for further action at NICMP end.

The meeting ended with a vote of thanks to the chair.
