Subject: Regarding Scholarship Portal of 2014-15.

A meeting was held on 31-12-2014 with the Nodal Officers of Implementing Departments regarding status of Post matric scholarship schemes for the year 2014-15, on portal. As per decision taken in the meeting large number of cases which were rejected by the sanctioning authority due to delay in their results and the data (36233) which is lying pending with the sanctioning authority without any reason, will be considered for scholarship in 2014-15. NIC will provide such data in excel sheets and will make provisions in the portal to generate such data at the level of line department immediately, so that line department could forward the data to the Welfare Department after getting it corrected from sanctioning authorities. Manual data will be forwarded by sanctioning authority to implementing departments and finally to the Welfare Department.

NIC will ensure to re-open the portal from dated 12-1-2015 to 18-1-2015 (mid-night) for sanctioning authorities and line departments to forward the pending data on line, to Welfare Department, so that department may not face any litigation in future.
